



## Cat Adopting Contract

Rev. 2.07.2017.

1. This Cat Adopting Contract (hereinafter referred to as the Contract) is entered into by and between the temporary custodian of the cat (hereinafter referred to as the Fosterer) and the person that is adopting the cat (hereinafter referred to as the Adopter). The contract was signed in the presence of the Witness.

2. The parties agree that the subject matter of this Contract is defining the rights and obligations of the Fosterer and Adopter during Cat's life.

## Terms of adopting

3. The cat is adopted without compensation.
4. The Fosterer and the Adopter have agreed that the Adopter will neuter or spay the Cat as soon as it reaches the appropriate age and not later than eight months of age.

## Rights and obligations of the Fosterer

5. The Fosterer hereby confirms that at the moment of adopting he has no knowledge of Cat's diseases in incubation period or genetic illnesses, and he believes the Cat is healthy.
6. The Fosterer hereby confirms that the Cat is properly vaccinated against rabies and infectious diseases and is treated against and free of internal and external parasites. The Fosterer will provide evidence for obligations in this Article.
7. The Fosterer will allow the Adopter and his licensed veterinary of choice to examine the Cat.
8. The Fosterer will help and advice the Adopter on adaptation of the Cat in new environment, also on care, feeding and training of the Cat.

## Rights and obligations of the Adopter

9. Obligation of the Adopter is to ensure that he will provide for the Cat's care, health and shelter according to Animal Welfare Act of Republic of Serbia of 2009.
10. The Adopter will allow the Fosterer to gain insight into the fulfillment of the provisions of this Contract, to respond to a request for a written information, to allow for a visit and to allow for a visit accompanied by a veterinarian.
11. The Adopter is obliged not to abandon, re-home or sell the Cat to another party without the written consent of the Fosterer.
12. The Adopter is obliged to inform the Fosterer without delay of following:
  - a. the Cat's tough, infectious or hereditary disease, disappearance, deceasing, etc.
  - b. the Cat's change of residence
  - c. inability to provide and care for the Cat.

## Final provisions and remarks

13. In case of violation of the provisions of this Contract, the Fosterer has the right to confiscate the cat without delay.
14. In case of violation of the provisions of this Contract, parties agree to accept the jurisdiction of the competent court in the Fosterer's place of living.
15. This Contract is executed and signed in four copies, the Fosterer retains two copies and the Adopter retains two copies.
