



Breed Cat Sales Contract

1. This Breed Cat Sales Contract (the "Contract") is made between the Seller and the Buyer, executed in the presence of a Witness. The subject of this agreement is the sale of a specific breed cat (the "Cat").

2. The parties agree that the subject matter of this Contract is defining the rights and obligations of the Buyer and Seller during Cat's life.

4. The Seller and the Buyer have agreed the following (choose):
- ☐ The Cat is sold as a pet, and the Buyer will neuter or spay it by 8th month of life. The Buyer will receive WCF pedigree after the procedure is confirmed by licensed veterinarian.
 - ☐ The Cat is sold as a pet, and the Buyer will neuter or spay it by 8th month of life. The Buyer will receive WCF pedigree with the Cat, with a restriction to breed.
 - ☐ The Cat is sold for breeding in a registered cattery. The Buyer will receive WCF pedigree with the Cat, with a permission to breed.
 - ☐ The cat will be neutered or spayed.
5. The deposit will be fully refunded if the seller fails to meet the terms of this contract.

Rights and obligations of the Seller

6. The Seller hereby confirms the following:
- The Cat's mother (Dam) is registered at WCF – World Cat Federation and has a valid WCF pedigree,
 - The Cat's father (Sire) is registered at WCF – World Cat Federation and has a valid WCF pedigree,
 - The Cat's birth is registered at WCF – World Cat Federation and the Cat has or will have a valid WCF pedigree.
7. The Seller hereby confirms the following:
- There is no indication of Cat's diseases, diseases in incubation period or genetic illnesses,
 - The Cat is able to eat solid food, it is free of parasites,
 - The Cat is or will be vaccinated and micro-chipped.
8. The Seller will allow the Buyer and his licensed veterinary of choice to examine the Cat.
9. The Seller will provide pedigree, ownership transfer document and cat's health record book.
10. The Seller will help and advice the Buyer on adaptation of the Cat in new environment, also on care, feeding and training of the Cat.

Rights and obligations of the Buyer

11. Obligation of the Buyer is to ensure that he will provide for the Cat's care, health and shelter according to local animal welfare acts.
12. The Buyer will allow the Seller to gain insight into the fulfillment of the provisions of this Contract, to respond to a request for written information, to allow the Seller for a visit and to allow for a visit accompanied by a veterinarian.
13. The Buyer is obliged not to abandon, re-home or re-sell the Cat to another party without the written consent of the Seller.

14. The Buyer is obliged to inform the Seller without delay of following:
- the Cat's illness, disappearance, deceasing, etc,
 - the Cat's change of residence,
 - inability to provide and care for the Cat.
15. In case of breeding the Cat, the Buyer will comply with all the legal provisions of WCF – World Cat Federation, in particular the Code of ethics for breeders and General conditions for husbandry and breeding cats.

Final provisions and remarks

16. The Buyer hereby confirms that at the moment of sale he checked the Cat and documentation and he believes that the Seller has fulfilled the provisions of this Contract.
17. In case of violation of the provisions of this Contract, the Seller has the right to confiscate the cat without delay.
18. In case of violation of the provisions of this Contract, parties agree to accept the jurisdiction of the competent court in the Seller's place of living.
19. This Contract is executed and signed in two copies, the Seller retains one copy and the Buyer retains one copy.
